GRADUATES OF THESE TWO CORE PROGRAMS ADVANCE TO CMC'S 120-DAY LIFE SKILLS TRAINING PROGRAM AS STUDENTS. THE INTENSIVE CURRICULUM PROVIDES SKILLS SUCH AS TIME MANAGEMENT, CONFLICT RESOLUTION, TASK COMPLETION, AND FINANCIAL MANAGEMENT, RELATIONSHIP-BUILDING. 


The undersigned, being the members of the Board of Directors of CHARLOTTE RESCUE MISSION SOCIAL ENTERPRISE, a North Carolina nonprofit corporation (the "Corporation"), and having voted at the April 1, 2024, Board of Directors meeting to dissolve the Corporation, do hereby waive any and all requirements for the holding of a meeting of the Board of Directors of the Corporation and do hereby take the following actions and adopt the following preamble and resolutions by signing our written consent hereto pursuant to Section 55A-8-21 of the North Carolina Nonprofit Corporation Act and do hereby approve and adopt the following Plan of Dissolution (the "Plan") of the Corporation:

1. Following approval and adoption of this Plan by the Board of Directors of the Corporation, a proper officer of the Corporation shall execute and cause Articles of Dissolution of the Corporation (the "Articles") to be filed with the Secretary of State of the State of North Carolina, and at such other place or places as may be required by law or may be advisable.
2. There being no members of the Corporation, no vote of membership is required to approve this dissolution, and action of the Board of Directors is sufficient.
3. After filing the Articles, the proper officer(s) of the Corporation shall cause a notice of the said dissolution to be mailed to each known creditor of the Corporation, if any, and, as the officers deem appropriate, may further cause said notice to be published one time in a newspaper of general circulation in the county in which the principal office of the Corporation is located.
4. The proper officer(s) of the Corporation shall collect all assets owing to the Corporation and shall pay and discharge, or otherwise make adequate provision for the payment and discharge of, all liabilities and obligations of the Corporation.
5. The proper officer(s) of the Corporation shall distribute any assets held by the Corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution of the Corporation, in accordance with such requirements.
6. The proper officer(s) of the Corporation shall pay all such fees and taxes, cause to be prepared and sign all such final tax returns and other documents, and do or cause to be done all such other acts that they may deem necessary or desirable in order to carry out and fully effectuate the purposes of this Plan pursuant to the North Carolina Nonprofit Corporation Act and applicable sections of the Code.
7. The proper officer(s) of the Corporation shall cause to be distributed and conveyed to CHARLOTTE RESCUE MISSION, a North Carolina nonprofit corporation and organization that is exempt under section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") as specifically designated and required in the Corporation's Articles of Incorporation, to be used for purposes for which this Corporation was formed, all of the residual assets of the Corporation in complete liquidation thereof.




